 - 2.4 **Documentation is to be provided** to ensure the traceability of the product and/or related sample.
- 3. Any "non conformity notice" or "client / shipyard claim" related to the above mentioned procedure to be forwarded to RINA Hamburg Office with relevant "corrective actions" taken as soon as possible.
